1. Introductions

Members of the meeting introduced themselves.

2. Minutes of previous meeting

Previous actions had been completed unless otherwise stated, with the following updates:

Action: Ashton Carruthers to look into the removal of the Sycamore tree. *Update – No further action would be taken; another Sycamore had seeded in place of the old tree.*

3. Update on development

The Housing Association homes adjacent to the Anstey Mill Close homes would be handed over w/c 29th October. The car park at the south-eastern corner of the site had been completed.

The fence line at the south-eastern corner of the site had been brought in by a couple of feet to create a larger ecological buffer at that part of the site.

The properties at the southern boundary (along the railway line) were progressing and would be handed over and occupied by Christmas.

There were currently around 40 occupations on site.

4. Questions/concerns from the community

Following questions from the community, the following was discussed:

- Would the new boundary at the western end of the site (adjoining John Eggars Square) be registered with the Land Registry?
- The ecological zone at the eastern end of the site was blocked for public access at both ends by a gate.
- There was work being done on-site on Sunday 21st October. It was suggested these were sub-contractors to the groundwork contractor.
- Wheelie bins were still being left at the roadside from nearby cottages.

Action: John Geoghegan to write to Neil Walker regarding trees at the back of #4 John Eggars Square.

Action: John Geoghegan to contact Land department at Miller Homes to see if boundary will be registered with Land Registry.
