

Alton Eastbrooke & Wooteys Residents Association AGM Thursday 7th April 2016

1. Previous Minutes

The minutes of the previous meeting were agreed. Members were keen to record Cllr Phillips' offer to swim in any further flooding on Geales Crescent.

2. AGM business

There were several outstanding issues at the Barley Fields development which were being addressed outside of this meeting.

It was hoped that the photos collected by the Traffic Sub-Committee would be put into a report.

Parking issues were raised at Victoria Road. It was suggested that this group liaise with the Ackender Road Residents Association, through ADRA, who were looking at the same issues.

"Lineage and signage" powers had been transferred from HCC to EHDC. John Geoghegan to pass on any information clarifying new responsibilities.
